Executive Summary

The CEI, celebrating its 30th Anniversary this year, has continued to play an important role in fostering its mission aimed at promoting European integration and sustainable development through effective regional cooperation.

In the increasingly challenging times for Europe, and also for the globe, regional cooperation has continued to prove to be one of the most efficient instruments for providing timely answers to complex issues. Current challenges do not stop at borders, they transcend them.

The CEI PoA 2018-2020 with its two far-reaching priorities - <u>strengthening connectivity</u> and <u>valorising diversity</u> in the region - as well as the related goals and objectives, has further served as a flexible and effective framework for tackling the challenges and for preparing the ground for new initiatives.

The number of traditional and new actions launched by the CEI throughout 2019 - in particular by the Italian Presidency and the Executive Secretariat — and aimed at: intensifying the political dialogue; enhancing the parliamentary and economic cooperation; pursuing cooperation with the UN, in the framework of the CEI's observer status in the UNGA; as well as strengthening cooperation with the EU and other international and regional organisations; are a clear indication in support of the above-mentioned.

Furthermore, the CEI has worked on enhancing its **project cooperation** through its funds and instruments. Out of its cooperation tools, the **CEI has organised, implemented and supported 90 projects and activities in 2019**, covering all the goals and objectives in the framework of the PoA, as follows:

- the CEI has engaged in actions in the field of <u>Good Governance</u> aimed at processing and exchanging experience on large-scale migration issues through the support of 3 projects and activities. It has also provided a platform for promoting safe and secure e-Government solutions, through the implementation and promotion of 3 projects and activities related in particular to the exchange of good practices related to eHealth. To strengthen institutional capacities and promote effective anti-corruption measures and open data, the CEI has organised, implemented and promoted 13 projects and activities;
- in the framework of <u>Economic Growth</u>, and in order to support the *strengthening of transport networks*, the CEI has organised, implemented and promoted 11 projects and activities, while 8 projects and activities have been implemented and promoted with the aim of *improving research and innovation systems*. The CEI has also launched and supported 5 projects and activities with the intention of *supporting transition to Circular and Bioeconomy and promoting Blue Growth*. As well, the CEI has worked on *strengthening rural and area-based development* by implementing or supporting 3 projects and activities;
- the CEI has undertaken and promoted a number of actions in the field of **Environmental Protection** aimed at fostering adaptation to climate change (4 projects and activities), promoting sustainable energy and energy efficiency (6 projects and activities) and preserving natural capital, especially biodiversity (1 project);
- the CEI has supported activities aimed at encouraging <u>Intercultural Cooperation</u>, in particular promoting intercultural dialogue and preserving cultural diversity, and this year 5 projects and activities have been promoted with the aim to achieve this objective. The safeguarding of cultural heritage and the supporting of creative industries have also been encouraged. In this context, 5 projects and activities have been supported. Moreover, 7 projects and activities aimed at fostering cultural diplomacy have been organised, implemented and promoted, while 2 projects and activities on improving social integration of people from groups at risk of exclusion have also been adequately tackled;
- the CEI has also supported activities fostering <u>Media Freedom</u>, especially for *promoting media pluralism*, transparency and independence (2 projects and activities) and for enhancing quality journalism (2 activities);
- finally, the CEI has promoted <u>Scientific Cooperation and Education & Training</u> by organising events and providing funding through its instruments aimed at *promoting international scientific cooperation and initiatives in support to science diplomacy* (4 projects and activities), *implementing life-long learning and developing competencies through mobility* (4 projects and activities) and *enhancing scientific literacy and technological knowledge and capacity* (2 projects and activities).

Introduction

The CEI Plan of Action 2018-2020 pays special attention to the real needs and proposals expressed by the CEI Member States for this three-year period, while also taking into account the evolving environment in the region.

It capitalises on the main strengths of the Organisation, based on its distinctive methodology for the promotion of regional cooperation through a combination of multilateral diplomacy and fund, programme and project management. While remaining a platform for political dialogue, in support of the European integration process and the sustainable development in the region, the CEI has developed a strong operational approach aimed at achieving these two strategic objectives.

The goals and objectives of the document are relevant to all CEI Member States and are pursued through goal-oriented multilateral cooperation, going beyond a purely intergovernmental dynamics, thus involving collaborative, multi-stakeholder partnerships. They involve both governmental and non-governmental actors – including civil society, business actors, scientific communities, academia and media. Furthermore, partnerships with other organisations are considered a part of normal working practice.

The goals and objectives of the Plan of Action are also fully in line with the Europe 2020 Strategy, the UN 2030 Agenda for Sustainable Development and the EU Macro-Regional Strategies also affecting the CEI area. The goals are interlinked, interdependent and represent the main areas of interest of the CEI Member States, as outlined in the CEI Guidelines and Rules of Procedure.

In practical terms, the CEI's main goal through the implementation of the Plan of Action is to bring its Member States closer together in joint initiatives and encourage further regional cooperation in a structured and result-oriented manner, while committing the Organisation to a continuous improvement of its performance.

Indeed, following the current challenges, and for creating further positive perspectives for the Region, the CEI has focused a part of its activities on developing a Youth Agenda and a Local Dimension, as recommended by the Ministers of Foreign Affairs in the "Trieste Declaration" of 12 June 2019.

Besides this new direction, the CEI is permanently working on the implementation of all goals and objectives included in the PoA 2018-2020, with focus on ensuring good governance, fostering climate resilience, promoting cultural values and scientific cooperation.

I. CEI Strategic Approach to Regional Cooperation

The CEI has been playing a key role in strengthening relations on various issues among its countries for already three decades. On its 30th Anniversary, the countries have reconfirmed their commitment to the CEI's mission as well as their determination to further develop the potential of the Organisation.

In particular, both the Italian CEI Presidency 2019 and the CEI-Executive Secretariat have pursued the goal of strengthening the CEI as a unique intergovernmental forum, with a varied membership and an agile structure suitable for facilitating political dialogue on many different topics. Thanks to its dynamism, the CEI has been promoted as a positive platform for exchange of experiences and good practices among its Member States, both in the context of European integration and in that of sustainable development, especially in the framework of multilateral international cooperation, starting with valuing the CEI Observer Status in the UN General Assembly.

These actions have been tackled through an intensified political dialogue and in cooperation with other international players, as well as through a strong project-oriented approach.

Intensified political dialogue

In line with the already established practice, the activities of the Italian CEI Presidency included: several meetings of the CNC, an annual formal meeting of Foreign Ministers (MFA Meeting), held in Trieste in June under the topic "Central European Initiative at thirty and towards the future: common vision, shared values, European standards, strong regional cooperation", an informal MFA meeting, held at the outskirts of the UN General Assembly in New York in September, and a meeting of the Heads of Government (CEI Summit), held in Rome in December.

The Presidency has also provided a tangible contribution to the sustainable economic, social, cultural and environmental development in line with the PoA 2018-2020. In this context, it has worked on the promotion of regional dialogue and cooperation, among others, in the fields of connectivity, fight against corruption, scientific cooperation and research. Therefore, numerous events have been organised on these topics.

In addition, the Presidency, supported by the CEI-Executive Secretariat, and in line with the recommendations by the Ministers of Foreign Affairs in the "Trieste Declaration" of 12 June 2019, has launched new actions related to the Youth Agenda and the Local Dimension.

The important outcomes and significant inputs gained from the MFA Meetings, Summit, CNC gatherings, high-level and expert conferences, events, forums, have contributed to significantly stepping forward cooperation towards European integration and sustainable development within the CEI Member States and on the challenges occurred throughout the year.

At the same time, the CEI-Executive Secretariat – under the new leadership composed of the Secretary General Roberto Antonione from Italy, the Alternate Secretary General Antal Nikoletti from Hungary and the Deputy Secretaries General Nina Kodelja from the Republic of Slovenia and Zoran Jovanovic from the Republic of Serbia – have also undertaken actions for promoting the CEI. In this regard, visits in almost all CEI Member States have been organised and meetings with a number of high-level government officials, high level members of Parliaments as well as representatives of Chambers of Commerce have taken place. The main aim of the visits was twofold: to present the new leadership of the CEI-Executive Secretariat and the CEI programmes and activities, and to listen to the views from the capitals on the future strategies of the Organisation. The discussions touched upon issues on how to further strengthen cooperation in the CEI framework by enhancing the political dialogue and through multilateral projects and activities with particular regard to the challenges currently faced by the region. In particular, Member States confirmed their commitment to continue their cooperation in the framework of the CEI. On many occasions, it was clearly mentioned that the CEI EU countries were ready to assist their non-EU CEI partners in achieving European integration objectives. Launching an agenda for the youth, as youth and their perspective is a common denominator for the future of societies in the entire CEI region, and including the local and regional authorities in the CEI activities, as they are closest to everyday life of the citizens, were underlined as possible new directions. Furthermore, an interest in getting more involved in science diplomacy, in particular in view of ESOF (Euro Science Open Forum) to be held in Trieste

in July 2020, was expressed. Finally, the high representatives highlighted the effectiveness of deeper cooperation among all international and regional actors in the Region.

The CEI activities have also included cooperation among parliaments. The Italian CEI Presidency organised the meeting of the CEI Parliamentary Committee, chaired by the President of the Italian CEI Parliamentary Delegation and entitled "Strengthening the local dimension of the Central European Initiative", held in Trieste in May. Under the leadership of the Bulgarian Chairman, the meeting of the General Committee on Political and Home Affairs of the CEI Parliamentary Dimension was held in Sofia in February. The main topics of the meeting were linked to the European perspective of the Western Balkans region, analysing synergies and perspectives of the integration processes, and exploring how to further increase cooperation among all CEI Member States. Furthermore, the meeting of the General Committee on Cultural Affairs of the CEI Parliamentary Dimension was held in Budapest in March, under the leadership Hungarian Chairman, and discussed a comprehensive tourism policy to stimulate the competitiveness of the economy in a sustainable manner, preserving natural and environmental values for future generations in the CEI Member States. Finally, the Parliamentary Assembly of the CEI Parliamentary Dimension, also chaired by the President of the Italian CEI Parliamentary Delegation, took place in Rome in November, where the discussion focused on the main topic "Developing Infrastructures for more Competitive Businesses in the CEI Area".

A <u>CEI Business and Experts Forum</u> was held in Milan in November and focused on the connectivity issue under the tile "Infrastructural and multimodal connectivity as factor of development and integration". The event, promoted by the Italian CEI Presidency in the framework of the CEI Economic Dimension, aimed at advancing the economic cooperation in the region.

Cooperation with other international players

The Italian CEI Presidency highlighted the CEI role as a facilitator of political dialogue and an accelerator of reforms, both at the European level and at a wider global arena. The CEI Observer Status in the UNGA was particularly valued. To this aim, on the occasion of the UN HLPF on Sustainable Development 2019, the Italian CEI Presidency, through the Italian Permanent Mission to the UN, and the CE-ES organised a side-event on "The contribution of regional cooperation and partnerships to the implementation of the 2030 Agenda: the experience of the Central European initiative (CEI)". The event, held at the UN Headquarters, aimed at exchanging knowledge and experiences with all relevant stakeholders regarding best practices of regional partnerships, such as the CEI, for the attainment of the UN Agenda 2030 in general, and the SDGs in particular. Furthermore, on the occasion of the informal MFA Meeting at the outskirt of the UNGA in September, the Ministers agreed on the establishment of a regular format of interaction between the Permanent Missions of the CEI Member States to the United Nations with the aim to better coordinate the actions within the UN.

Cooperation with the EU, and in particular with the EC, has always been one of the main priorities, in particular related to the perspectives for those CEI countries aspiring EU membership or establishing closer ties with the EU. With this aim, the CEI has opened a Representation Office in Brussels in order to increase the CEI visibility, thus strengthen ties with the EU institutions. EU representatives participated in several CEI meetings during the year at both political and project level. Moreover, a fruitful meeting between the CEI National Coordinators, Permanent Representations and high level officials of the EC and the European Parliament was held in Brussels in May. In addition, cooperation with various Directorates General of the Commission continued in the framework of the CEI EU-funded projects. Presentations of the COME-IN! Final Conference and Award Ceremony and of the NAMIRG Project were also held at the European Parliament in Brussels in September and December, respectively. Moreover, the CEI further enrolled in the implementation of the EU Macro-Regional Strategies and actively participated in a number of events in the context of the EUSDR, EUSAIR and EUSALP.

Particular attention was paid to enhancing synergies with other international and regional organisations active in the region. It aimed at establishing common actions and identifying joint projects. In this context, the CEI had explored the possibilities for joint activities in the field of anti-corruption, local dimension, youth & culture, in a meeting with the CoE, comprising a presentation at the Group on External relations (CoE GR-EXT) and bilateral

meetings with CoE's high officials. Furthermore, a Memorandum of Understanding between the CEI and the All was signed in Budva in May, aiming at fostering regional cooperation and sustainable development and moving further steps for preparation and implementation of joint activities. A Memorandum of Understanding was also signed with the RAI Secretariat in Rome in November to further cooperation between the two counterparts on the topic of anti-corruption. A project of BSEC on inter-basin cooperation on marine litter, with a focus on the Danube River and the Black Sea, was supported by the CEI and implemented in Sofia in April. In addition, focusing on possibilities for synergies and cooperation with other regional players, a CEI-WBF meeting was held in Trieste in February, aimed at exchanging information about respective programmes and activities in the Western Balkans. A CEI-RCC meeting was also held in Trieste in March. Cooperation with the European Training Fund (ETF) high-level representatives, who paid a visit to the CEI-ES in September, was also explored. ETF's high expertise on human capital development and related opportunities offered thereby to a large portion of CEI Member States, represent an important potential for a successful cooperation between the two Organisations. Finally, in Barcelona in November, the CEI-ES took part in the Coordination Meeting of Regional Organisations organised by the UfM Secretariat, with the aim to exchange information and create synergies among the regional organisations (AII, BSEC, CBSS, CEI and UfM) as well as to explore the possibilities of cooperation as regards the Climate Action. Besides these activities, cooperation has been pursued through a regular reciprocal participation of partners in various events and activities, including with the OSCE.

CEI project-oriented approach

In 2019 the CEI, and in particular the CEI-ES, continued the project cooperation through its operational instruments of cooperation:

- Cooperation Activities (co-financed out of the CEI Cooperation Fund, contributed by all CEI Member States)
 the activities mainly promote networking and people-to-people contacts, such as conferences, seminars, workshops, festivals, cultural and youth exchanges, educational and science meetings, media events, etc. on topics where smaller amounts make an effective impact. The utility of this instrument is demonstrated by the fact that a large number of applications for co-financing requests have been submitted this year.
- Advanced Training Programme for Young Professionals (fully financed out of the CEI Cooperation Fund) the CEI is strongly promoting learning-at-workplace activities. In this context, throughout 2019 it has engaged several young professionals in the area of liaison and external relations, communication and project management (from the Republic of Albania, Bosnia and Herzegovina, Hungary, Montenegro and the Republic of North Macedonia). After their training period, they are expected to return to their countries and apply the knowledge gained during their stay at the Executive Secretariat in Trieste.
- Feature Events and Prizes the CEI has further promoted its "Feature Events". They are events, which are recurrent in nature and highly contribute to enhancing the CEI visibility. These events either carry the name of the CEI in their title or dedicate a special segment to the CEI, providing valuable opportunities for networking, training and mobility in the fields of media, intercultural cooperation and life-long education and training. Moreover, in order to honour and encourage initiatives and activities of talented and often young people from CEI Member States, several Prizes have been offered, in particular in the fields of culture and media.
- <u>KEP</u> (financed out of the CEI Fund at the EBRD funded by Italy) the CEI has paid special attention to the promotion of joint projects between the EU and non-EU CEI Member States related to transfer of know-how, exchange of experience and capacity building, such as trainings, study visits, etc. Indeed, this specific Programme, has proven to be the most efficient and stimulating mechanism for the transmission of best practices in all areas of activity. As an outcome of this year's Call, 8 KEP Italy projects were approved with 270,075 EUR (CEI Grant).
- TC Programme (financed out of the CEI Fund at the EBRD, entirely funded by Italy) through this Programme the Fund offers grant-type assistance in support of specific components of investments and operations of the EBRD. TC operations include support for feasibility and pre-feasibility studies, sector and environmental engineering, management training, capacity building, pre-loan audits. The CNC has recently approved the financing of five TC projects by the CEI Fund at the EBRD. These projects will target all the non-EU CEI Member States in priority sectors such as energy, transport and capacity building for a total cumulative cost of 675,000 EUR.

EU-funded Projects – the CEI, through its Executive Secretariat, makes use of EU funding programmes as a valuable tool for the attainment of one of its strategic objectives - the promotion of regional cooperation for European integration – as well as for the implementation of its tri-annual Plan of Action. The CEI-Executive Secretariat is currently involved in 17 EU-funded projects with a total amount of about 31 million EUR of which about 3.2 million EUR administered by the CEI-Executive Secretariat in a number of areas such as transport, energy, research and innovation, judicial cooperation, environmental protection, bioeconomy, social innovation, culture. Additional 3 EU-funded projects were finalized during 2019.

II. CEI Agenda for 2018-2020

The Agenda, covering a three-year period (2018-2020), represents a focused and project-oriented roadmap aimed at promoting regional cooperation on various issues related to the implementation of the CEI's mission, with two main denominators, i.e. strengthening connectivity and valorising diversity in the region. It is also capitalising on the main strengths of the Organisation, based on its distinctive methodology of combining multilateral diplomacy through intense political dialogue, and operational approach through fund, programme and project management.

The activities dedicated to the goals and objectives established within the PoA, address the core challenges and opportunities for CEI Member States reflecting a common vision of the economic, social and environmental prosperity of the region attained through joint actions. In this context, the CEI has launched, supported and organised a high number of actions in close cooperation with stakeholders from the CEI Member States (Governments, Ministries, Expert groups, Regional organisations and institutions, NGOs).

I. Strengthening Connectivity

Goal 1: Good governance

In 2019, the CEI continued to foster good governance aimed at preserving long-term stability and security, by exchanging experience on large-scale migration issues, promoting digital services, in particular in the health sector, and encouraging accountable institutions, in particular regarding the promotion of effective anti-corruption measures, fair public procurement, improved investment climate and encouraging a favourable environment for SMEs. The following activities have been implemented:

1.1. Processing and exchanging experience on large-scale migration
